COMMENT PERIOD: The City of Miami Beach is making available for public review and comments its draft One-Year Action Plan for federal funds for Fiscal Year 2015/2016 during a thirty-day comment period that begins on July 09, 2015 and ends on August 07, 2015. The One-Year Action Plan outlines the use of federal funds received by the City of Miami Beach from the U.S. Department of Housing and Urban Development (HUD). Citizens are encouraged to review the draft Plan, which includes funding recommendations for the Community Development Block Grant (CDBG) Program, and the HOME Investment Partnerships (HOME) Program. The draft Plan will be available at the Office of Housing and Community Services.
