SUBJECT: Evaluation Committee Relative to Invitation to Negotiate (ITN) No. 2016-084-WG, for Administration of the City's Ancillary Health Benefits for Employees, Retirees and Their Dependents - Family and Medical Leave Act (FMLA) Administration; Long-Term and Long-Term Disability; Group Dental Coverage; and Group Term Life and Accidental Death & Dismemberment Coverage
